- Unless other arrangements have been made, if payment is not received by the fifth of the month, a \$35.00 late fee charge will be applied.
- Refunds will be given with a sixty day written notice if you decide to withdraw your child from the program.
- A **non-refundable deposit of \$400.00** is due with this form at the time of enrollment that will be deducted from the first payment.
- Refunds or make-ups for days absent due to illness, holidays, days closed as indicated on school calendar, or vacations will not be made.
- Parents picking up late will be charged after the first five minutes \$1.00 per minute.
